Completing the Good Standing Application – Form GGA 1

<u>Form GGA 1</u> must be completed by an <u>Agent of a Lottery or Betting shop</u> applying for a Good Standing certificate.

Answer every question completely. Do not leave blank spaces.

SECTION A: BUSINESS INFORMATION

- **A1**. **Business Name**: Fill in the name exactly as it appears on the Certificate of Registration.
- **A2**. <u>Trading Name</u>: Fill in the name under which the business operates, if different from the registered business name
- **A3**. <u>Business Address</u>: Fill in the address at which Lottery or Gambling and Betting activities are to be conducted including lot number, street address, town or village of the business.
- **A4**. **Business Owner**: Fill in the name of the person(s) whose name(s) appear on the Certificate of Registration.
- **A5 A8**. <u>Business Contact details</u>: Fill in the telephone and fax numbers, E-mail address and Website (if applicable) of the business.

A9. Business Formation:

Business Registration - Fill in the day, month and year the business was registered.

Place of Registration – Fill in the city/town and country the business was registered.

Type of legal Business Entity - Check one box, indicating the type of business entity.

Business Owner(s) – Fill in the name of the person(s) whose name(s) appear on the Certificate of Registration, for example, if you are the sole owner, therefore, you own 100 percent of the business.



SECTION B: PERSONAL HISTORY

B1. Details of Applicant:

<u>First and Last Name</u>: Fill in your legal first and last names, as they appear on your national ID document.

Former/Other names: Fill in any name that you also may have been known by, for example your maiden name or aliases.

<u>Date of Birth</u>: The day, month and year of your birth.

Place/Country of Birth: The village or town where you were born, for example, Georgetown.

B2. <u>Passport and ID Details</u>: The passport and ID card numbers as issued by the Issuing authorities, for example, Passport office of Guyana and Guyana Elections Commission.

<u>Place of Issue</u>: The *village or town* where your passport and ID card were issued.

Date of Issue/Expiration: The day, month and year when the passport was issued and will expire.

B3. **Physical Description**: Fill in your current height and weight, colour of eyes, hair, complexion and any distinguishing marks. *This information can be found on the back of the ID card.*

B4. Residential Address: List all the addresses where you have lived for the last five (5) years, beginning with your present address (Example, Lot 000, ABC Street, Georgetown. From Jan/20XX to Present month and year).

B5. <u>Details of your Spouse</u>: If any, list the legal last and first names, date of birth, place and country of birth and country of residence of your spouse. If not applicable, <u>DO NOT</u> leave blank, fill in "N/A".



Spouse Occupation: Give a description of your spouse's current occupation. If self-employed, please indicate.

Spouse Residential Address: The complete home address of your spouse.

- **B6**. <u>Details of your Father:</u> List the legal last and first names, place of birth, date of birth, country of birth and country of residence of your father.
- **B7**. <u>Details of your Mother:</u> List the legal last and first names, place of birth, date of birth, country of birth and country of residence of your mother.
- **B8**. <u>Details of Children:</u> List the legal last and first names, place of birth, date of birth, country of birth and country of residence of your children.
- **B9**. <u>Details of Brothers and Sisters</u>: List the legal last and first names, place of birth, date of birth, country of birth and country of residence of your siblings.
- **B10**. Employment information: List the name of the employers you worked for during the last five (5) years including the business listed in question A1, for example, From Jan/20XX to Dec/20XX, sole proprietor, ABC Ltd, Georgetown, Variety store.
- **B11**. **Declarations**: Please answer each question truthfully. If you answer "yes" to question (I), please list each arrest and/or conviction on an attached sheet of paper. Include the month and year of each incident and the outcome.

<u>Individual Release Authorization and Affidavit of Truth</u>: The forms <u>must</u> be completed for each applicant and **signed** before a Notary Public, Commissioner of Oath or Justice of Peace.
